FEBRUARY

Family Violence Protection Act 2008

DVRCV together with Women's Legal Service Victoria (WLSV) has developed a 2-day training program on the Family Violence Protection Act 2008. The training provides an overview of the Australian Legal System as a whole; and identifies:

- ◆ What sort of laws apply in family violence cases & where family violence cases are dealt with in that system
- ◆ How to support women to access protection under the Family Violence Protection Act 2008, including information about Intervention Orders; Rules of Evidence; Family Violence Safety Notices; Women's rights under the Act; Children and intervention orders; exclusion orders and tenancy issues

Family Violence Risk Assessment

This one day workshop will provide an opportunity for a range of practitioners to gain essential knowledge and practice skills in using the Family Violence Risk Assessment and Risk Management Framework tool (also known as CRAF).

The Framework has been developed by the Victorian Government to provide a consistent response to assessing family violence risk factors across the whole community services sector. The training is focussed on promoting the safety of women and children as the primary victims of family violence and how service systems may work collaboratively to manage and reduce the risk to families and the community.

Not Seen or Heard: the Effects of Domestic Violence on Children

(Accredited Unit CHCDFV408C)

This three-day training program aims to provide practitioners with the knowledge and skills required to provide support and information to children and young people who have experienced domestic and family violence. The training covers: creative techniques for engaging children; exploring issues and developing safety and therapeutic plans; providing support, advocacy and information; and the importance of reparative work with the mother.

By completing this training, additional reading and assessment tasks, participants can achieve the nationally accredited unit CHCDFV408C: Provide support to children affected by domestic and family violence.

Pre-requisite: completion of 'Introduction to Domestic Violence' or equivalent (either training or work experience).

The topics covered in the session will include: models for taking case notes; writing style and context to cover legal issues; responding to a subpoena; being a witness; and writing reports for court.
